

ADOPT TO REHOME FROM HCAS PILOT PROGRAM RULES

1. This is a pilot program limited to the cat rescues selected to participate at this time. The rescues participating are: Cat Crusaders, Cat Call, Saint Francis, and the Humane Society of Tampa Bay.
2. The rescues are not required to participate in this program, and it is not mandatory on them that they help anyone re-home a cat adopted from HCAS. The rescues will participate as availability of adoption space is available to them.
3. It is the responsibility of the adopter to contact and work out the details of re-homing the adopted cat with the individual rescue the adopter chooses to work with for this purpose. The rescues urge the adopters to work with the rescue located closest to the adopters home.
4. It is the responsibility of the adopter to provide a copy of the HCAS medical form for the cat to the rescue.
5. The rescues participating agree to furnish adoption information and certify to HCAS when your adopted cat has been re-homed so that you make select another cat from HCAS to adopt.

6. The rescues will not reimburse your adoption fees, but HCAS has agreed to waive the future adoption fee for the next cat you select to adopt.
7. Current fosters for animal rescues are excluded from this program.

1. I agree that I legally own this cat or kitten until such time as the cat or kittens are adopted, in which events the attached surrender form will become effective, but not before such time. _____

I understand that the Rescue group will not provide vet care, food or litter, and I am responsible for providing for the cat or kittens until adopted, except when the cat or kittens are shown in the store, when the Rescue will provide food and litter temporarily but is not accepting ownership of this cat or kittens. _____
4. I agree to foster this cat or kittens until the cat or kitten is adopted out by the Rescue and this cat or kittens will remain inside only. _____

5. I agree to bring this cat or kittens for adoption at the store the Rescue shows at when space is available for the cat or kittens to be shown for adoption. _____
6. I agree to stay in touch with the foster coordinator concerning when space is available and to bring the cat or kittens for adoption from Sat a.m. to Sun p.m. _____
7. I understand that this is an all-volunteer organization, and there are set hours at the adoption center for the weekend. I further agree that I will communicate concerning drop off and pick up times and, absent an emergency, will not keep volunteers waiting for me to pick up my cat or kittens. _____
8. I understand that there is not always room for cats or kittens to stay during the week, but when there is room for my cat or kittens to stay in the store, I agree to allow my cat or kittens to stay in the store for the week. _____
9. I understand that if I choose to re-home this cat on my own or keep this cat, the rescue WILL NOT certify to HCAS that this cat was re-homed through the rescue. _____
10. I understand that the rescue will not lower their adoption standards to re-home this cat, and any person I find on my own to adopt this cat must meet the rescue's standards for the rescue to certify to HCAS that the cat was successfully adopted. _____
11. I agree that if I fail to abide by paragraphs 1 through 9 above, I will be excluded from this program. _____
12. I agree that if I fail to pick up my cat or kittens, I will be responsible to reimburse the Rescue \$500.00 per cat or kitten for indefinite boarding. I further agree that I will be responsible for all legal fees incurred by the Rescue for the collection of these fees. _____

Terms of Surrender

I. Terms of Release

We, the surrendering owner(s), hereby agree to irrevocably surrender to Cat Crusader's Inc the above described cats/kittens. We forego all present and future rights, privileges, and claim to this animal.

II. Owner's Representations and Warranties

We hereby represent and warrant to Cat Crusaders, Inc, their agents, successors and assignees, that we are the sole owner(s) of the above described cats and that we have unabridged authority to surrender this animal. We further assert that we are registered as the sole owner(s) cat, and require no other individual or institution's permission to affect a transfer of ownership of said pedigree registration papers. No other individual or institution has any legal or equitable interest in this animal.

III. Owner(s) Document and Information Provision

We agree to provide Cat Crusaders, Inc with any documents and all other available information concerning this cat that may facilitate matching this cat with the proper adoptive home. These documents may include veterinary records, vaccination records, medication lists, all vet contact information and pedigree registrations.

IV. Owner(s) Surrender of Rights

With the execution of this document, we cede all rights, title, privileges, and interests in the aforementioned cat. It is understood that this revocation extends to all future decisions concerning this cat made by the CAT CRUSADERS, INC including medical and adoption requirements. We further stipulate that the CAT CRUSADERS, INC has sole discretion in determining whether the cat's temperament, health, especially chronic, irreversible, life-threatening, and/or painful ailments render the cat unsuitable for adoption, requiring unforeseen actions, including euthanasia.

V. Release and Indemnity

We agree and understand that herewith we release and hold harmless Cat Crusaders, Inc from any and all liability arising from the placement for adoption or any other necessary and appropriate action undertaken by the CAT CRUSADERS, INC on behalf of the aforementioned cat in accordance with and in reliance on the representations made and the authorizations given under the terms of this document.

We agree to hold harmless CAT CRUSADERS, INC and its officers, members, and representatives from any damages suffered, expenses incurred, including legal fees in defending or pursuing any legal action, whether for bodily injuries or death, property damage, breach of contract or otherwise, whether instituted by us or by any other individual(s) including the adoptive owners, arising out of or in consequence of the placement of this cat, in reliance on the authorizations, representations, and guarantees we have made in this agreement.

This constitutes the entire agreement between CAT CRUSADERS, INC and us and no other terms or conditions are granted or implied.

THIS IS A LEGALLY BINDING DOCUMENT FOR THE SURRENDER OF THE AFOREMENTIONED CAT. PLEASE READ THIS CONTRACT CAREFULLY AND COMPLETELY. BE CERTAIN YOU UNDERSTAND ALL TERMS BEFORE SIGNING.
